## Enter the CFA® Program

Enrollment Requirements:

Have a ***bachelor's (or equivalent) degree***

OR

Be an ***undergraduate student***



Your selected exam window must be 23 months or fewer before your graduation month for your bachelor's degree or equivalent program.

OR

Carried out professional ***work experience***

Have a combination of ***4,000 hours of work experience and/or higher education*** that was acquired over a minimum of three sequential years<sup>^</sup> and achieved by the date of registering for the Level I exam. The dates of education and professional work experience cannot be overlapping.



A ***valid international travel passport*** is required to register.

<sup>^</sup>If applicable, assume 1,000 hours per year for higher education



## Become a CFA® Charterholder

After passing all three exam levels, complete these steps to become a Charterholder:

- At least 4,000 hours of relevant experience, completed in a minimum of 36 months
- Submit 2-3 professional references
- Become a member of CFA Institute (USD299 membership fee for CFA Institute\*)

\*First year annual dues will be pro-rated for those joining CFA Institute and a member society for the first time.
