Enrollment Policy

- (1) A completed enrollment form/order must be accompanied by FULL PAYMENT.
- (2) Kaplan Test Prep and Admissions reserves the right to cancel a course due to insufficient enrollment. Under such circumstances, Kaplan will facilitate a free transfer into another Kaplan course or provide a full refund within one (1) month of course cancellation.
- (3) Kaplan reserves the right to make alterations regarding course instructors, class locations, topic sequence and time allocated to each topic if necessary.
- (4) Course Acknowledgement will be emailed to students and guardians (if applicable) approximately three (3) working days prior to course commencement.

Identification Policy

- (1) Except Online Course, all students enrolling a course must hold a permanent HKID or a study visa. Kaplan reserves the right to verify student's identity whenever students are present for a course, using or making request of our services. This involves verification of student's contact information and showing of HKID card or passport. The identification document must be current and valid.
- (2) Under all circumstances, only the enrolled and paid students can attend our lectures or use the student supporting services.
- (3) Students who have entered the Kaplan premises will be bounded by Kaplan's terms and conditions.

Attendance & Video Catch-up Policy (Not applicable for Online Course students)

- (1) As email is the primary contact between Kaplan and students and guardians (if applicable), it is students' and guardians' responsibility to check their email regularly. Only urgent notice will be communicated by phone and/or WhatsApp.
- (2) It is students' responsibility to attend the course sessions according to the course timetable. Two (2) swaps for online video catch-up are allowed per enrolled course and request must be made three (3) working days prior to the session. The swap policy is only applicable to IELTS Speaking and Listening, IELTS Reading and Writing and IELTS Intensive.
- (3) Online video catch-up will only be valid on the reserved day for 24 hours and no re-swap is allowed.
- (4) Live lessons will be audio and video recorded. Upon enrollment, students shall give permission to the recording for internal use and online video catch-up.
- (5) The online video clips are copyright protected. They are solely available for student's viewings in person. No person shall sell, resell, transfer, sub-license, lease, assign, lend, rent, or otherwise redistribute the online video clips to any third party.
- (6) Kaplan does not warrant the quality of the online video clips. They are offering on the "status quo" basis. Therefore, some occasional interruptions or signal errors may occur within the viewing period.
- (7) Attendance Certificate is only issued for students who have attained 80% or above of attendance record. Official attendance certificate may be requested for a fee of HK\$50 per copy.

Course Materials

- (1) All course materials are to be collected in person, accompanied by an official receipt. Distributed materials (e.g. books, CDs, online accounts) are non-refundable.
- (2) Students are responsible to bring course materials and corresponding equipment to course sessions and practice tests. No materials or equipment are available for borrowing.
- (3) Course materials are non-refundable.

Online Course

- (1) Online Courses are non-transferrable and non-refundable, and not eligible for cancellation and alteration of subscription start date, regardless of time spent on the course and whether you have accessed to the course.
- (2) Online Courses will be using Kaplan e-learning platform.
- (3) Please view the demo link for at least 10 minutes on your computer which you will access online course and check the box on the enrollment form if your testing is satisfactory.
- (4) Activation of online account (e-Learning) takes three (3) working days. Do not choose a start date that falls on weekend or Hong Kong's public holiday. Inappropriate start date chosen will be postponed to the earliest start date available without notice.
- (5) Course materials will be digital copy. Downloadable for once only and non-printable.

Mock Test

- (1) Mock test fee is non-refundable but can be redeemed as the corresponding course fee when students enroll in corresponding Kaplan course. For multiple mock test subscriptions, only one (1) mock test fee can be redeemed.
- (2) One (1) schedule change is allowed for each mock test enrollment and Kaplan must be notified at least three (3) working days in advance. Failure will result in forfeit of mock test.
- (3) Results of written mock test will be released within one (1) week upon completion of mock test.

Course Retake (For Live Courses only)

- (1) Course Retake Services are non-transferrable and non-refundable.
- (2) Course retake is not inclusive within the Combo Package. Students enrolled with the Combo Package must purchase the course retake for each of the course within the Combo Package.
- (3) Course Retake can only be redeemed once per purchase within one (1) year.
- (4) Course Retake Services can only be purchased within one (1) month from the completion date of original enrolled course.
- (5) Course Retake will NOT include course materials. Students may purchase the materials at applicable fee.
- (6) Enrollment policy applies to Course Retake Services.

Kaptest Care

(4) For Online Courses:

Transferral, Withdrawal and Refund Policy

- (1) Except IELTS Exam Drill, all transferral, withdrawal and refund requests must be submitted to Kaplan at least 14 working days before the paid course commencement date.
- (2) All requests are subject to an administration fee of HK\$300 per request.
- (3) No refund nor withdrawal requests are permitted for IELTS Exam Drill.

Score Guarantee Scheme (Only applicable to IELTS Exam Drill)

If students cannot obtain an overall official band score of 7.0 upon completion of the IELTS Exam Drill with 100% attendance in real-time, students can apply to access online catch-up videos for 180 days.

Personal Data Protection

- (1) Your personal data is collected and used by us for processing your application of admission, and for registration, administrative, verification, research, statistical and direct marketing purpose. We may also collect personal information to satisfy legal, government and statutory obligations. Provision of personal data is necessary, and without your personal data, we may not be able to provide you with services you require. We may share and transfer your personal data with other members of the Kaplan group and/ or authorized third parties providing services to us in relation to the above purposes and/ or other prescribed purposes as allowed by law from time to time. In all such circumstances, data will be treated in strict confidence.
- (2) Under the provisions of the Personal Data (Privacy) Ordinance, applicants have right to request access to, and to request correction of, his or her personal data. Applicants wishing to amend his or her data should fill out the prescribed form and submit it to Kaplan. Applicants may opt-out from receiving our direct marketing materials at any time.
