About Programme

關於課程

This programme is designed specifically for people who are interested in working within an accounting function in business, commerce, finance or entering into the accounting profession. During the programme, students will become skillfully acquainted in financial accounting, management accounting, taxation and auditing; and be able to undertake projects investigating contemporary problems of accounting. The degree seeks to ensure exemptions from the Association of Chartered Certified Accountants (ACCA) and the Chartered Institute of Management Accountants (CIMA) professional syllabus. The degree, with papers' exemptions from the ACCA and CIMA qualifications, will give students the greatest flexibility when choosing their career, whether it is auditing, taxation, management accounting, financial reporting or management consulting.

Each semester lasts for 6 months, in which 2 units are covered concurrently. Each unit, contains 67 hours of seminars, except "Specialist Project in Accounting", which contains 26 hours of seminars. All classes are conducted at non-office hours during evenings, weekends and public holidays.

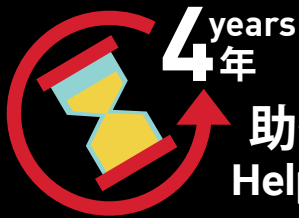
